INVITATION TO BID SOLID TIRES AND WHEEL ASSEMBLIES

- 1. The Calhoun County Commission will receive competitive sealed bids from qualified bidders for the purchase of four (4) **Solid Tires and Wheel Assemblies,** required by the Calhoun County Landfill/Transfer Station, and including shipping and delivery and installation of the four (4) tires, mounted on wheel assemblies to the Calhoun County Landfill/Transfer Station, 3625 Morrisville Road, Anniston, Alabama 36201.
- 2. The bidder shall furnish a draft copy of the warranty information with his/her/its bid. The selected bidder shall submit to Calhoun County upon delivery a warranty certificate. Bidder may submit additional warranty options as an exception to the bid. Exceptions to the bid must be submitted and included with the bidder's bid and shown as "EXCEPTION(S) TO BID CONDITIONS AND SPECIFICATIONS".
- 3. Sealed bids with the words "Solid Tires and Wheel Assemblies", on the outside of the envelope or package containing the bid, must be submitted to the Calhoun County Commission, 1702 Noble Street, Suite 103, Anniston, Alabama 36201, no later than _June 6, 2025, at 2:00 P.M., Central Time. Bids sent by facsimile transmission, email, telegraph, or telephone will not be accepted. Bids shall be opened and read aloud on Thursday, _June 6_, 2025.,at2.00 PM Central Time, in the Calhoun County Commission Meeting Room in the Ken Joiner Calhoun County Administration Building, 1702 Noble Street, Anniston, Alabama.
- 4. Specifications for the Solid Tires and Wheel Assemblies are as follows:
 - Tires are to be of solid rubber design
 - The machine, on which the tires are to be used, is to be operated on pavement, concrete, and steel surfaces.

- Wheels are to be designed to fit and shall fit a Caterpillar 930m wheel loader
- Tires are to be mounted on steel wheels before being shipped.
- The dimensions of each tire, are as follows: 20.5x25.
- State the warranty provided on the wheels and tires
- •State the number of days if awarded the bid, that the tire and wheel assemblies will be delivered and installed
- 5. A bid bond in the amount of 5% of bid amount with the bid bond not to exceed \$10,000 or a certified check, in lieu of a bid bond, payable to the Calhoun County Commission in the amount of 5% of the bid amount, with the amount of the certified check not to exceed \$10,000, must be furnished to the Calhoun County Commission along with the bid being submitted. Note: Personal checks will not be accepted in lieu of bid bond or certified check. Failure to provide bid properly executed bond or certified check with a bid will cause bid to be rejected.

- 7. The selected bidder will be required to submit a properly completed and executed Internal Revenue Service Form W-9 and a Calhoun County Business License, (for new vendors Affiidavit, Certificate of completion, e verify mou) if and as required, to provide tires and wheel assemblies as herein sought.
- 8. Notwithstanding anything else herein provided, the Calhoun County Commission reserves the right to reject any and all bids, and to waive technical errors, if in Calhoun County Commission's judgment, the best interests of Calhoun County and the Calhoun County Commission will thereby be protected and/or served. The Calhoun County Commission also reserves the right to the fullest extent allowed or not prohibited by applicable laws and regulations, negotiate with the lowest responsive, responsible bidder selected.
- 9. Notwithstanding anything else herein provided, if a bid is awarded, it shall be awarded to the lowest responsive, responsible bidder.
- 10. The selected bidder's attention is directed to the fact that all applicable federal and state laws, municipal ordinances, and rules and regulations of all authorities having jurisdiction shall apply to the contract awarded.
- 11. The bidder expressly acknowledges, to and for the benefit of the Calhoun County Commission, that, bidder expressly warrants and agrees that he, she, or it shall at all times comply with all applicable federal, state, local and municipal laws and ordinances and regulations.
- 12. Bids may be mailed to the Calhoun County Commission, 1702 Noble Street, Suite 103, Anniston, Alabama 36201, early enough that they are received prior to the bid opening date and time. The Commission cannot and does not guarantee that bids sent by mail or courier will be received on or before the bid opening day and time as required. Bids received after the deadline for bids will not be accepted and will be returned.

- 13. By accepting the bid award, the contracting parties affirm, for the duration, that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the state of Alabama. Furthermore, a contracting party found to be in violation of this provision shall be denied in breach of the agreement and shall be responsible for all damages resulting therefrom.
- 14. By accepting the bid award, the contracting parties affirm, for the duration of this agreement to remain in compliance with Act 2016-312, the Parties hereby agree that they are not currently in, and will not engage in, the boycott of a person or an entity based in or doing with a jurisdiction with which this state can enjoy open trade.
